

PRIVACY POLICY

Phoenix Bridal Show is committed to protecting your privacy. This Statement of Privacy applies to Phoenix Bridal Show Web site and governs data collection and usage at all Phoenix Bridal Show sites and services; it does not apply to other online or off-line sites, products or services. By law, our affiliates must include an "opt out" option on any and all electronic emails sent to you that would allow you to easily and permanently be removed from their email campaigns. We do not sell our list to third parties not affiliated with our events.
